



Information regarding travel sanctions: Fiji

About the information you give

The information you provide will be used to determine if you are subject to Australian Government autonomous travel restrictions against those responsible for the December 2006 military coup in Fiji and appointees of Fiji's interim Government.

Making a false or misleading statement in respect of entry to Australia may result in the refusal of your visa application or, if a visa has been granted, in the cancellation of your visa.

The information collected in this form may be provided to other Australian Government departments and agencies to determine if the sanctions apply.

The department is authorised to collect information provided on this form under Part 2 of the *Migration Act 1958* 'Control of Arrival and Presence of Non-Citizens'. The information provided will be used for assessing your eligibility for a visa to travel, enter and remain in Australia and for other purposes relating to the administration of the Migration Act, for example, to assist migrants with settling in Australia or for ensuring compliance with the Migration Act.

The department may disclose information you provide to other government departments or agencies to assist in assessing your application or to ensure Australian laws are complied with.

The information provided might also be disclosed to agencies who are authorised to receive information relating to adoption, border control, business skills, citizenship, education, health assessment, health insurance, health services, law enforcement, payment of pensions and benefits, taxation, review of decisions and registration of migration agents.

The collection, access, storage, use and disclosure by the department of the information you provide in this form is governed by the *Privacy Act 1988* and, in particular, by the 11 Information Privacy Principles. The information form 993i *Safeguarding your personal information*, available from the offices of the department, gives details of agencies to which your personal information might be disclosed.
